2. Alterations and repair work determined by the Mechanical Official to be of a minor nature.
3. Business, mercantile, and storage buildings having HVAC equipment only, with one fire area and not more than 3,500 square feet.
4. Work completed by a governmental subdivision or state agency costing less than \$15,000.00.

VI. HOMEOWNER AFFIDAVIT

VII. FEE CLARIFICATION

Item #12, Residential Heating System: This item is used for the installation of a heating system in a new residential structure. Items #11 Gas Piping and item #22 Duct should not be charged. Replacement items should be itemized.

Item #4. Residential Boiler: A residential boiler must be installed by a licensed boiler installer. Provide boiler installer license number in Section II, above.

Items #15 and # 17. Tanks: A homeowner must own the tank to be installed. If a Homeowner does not own the tank, a licensed mechanical contractor must install the tank.

IX. INSTRUCTIONS FOR COMPLETING APPLICATION

General: Mechanical work shall not be started until the application for the permit has been filed. All installations shall be in conformance with the Michigan Mechanical Code. No work shall be concealed until it has been inspected. When ready for an inspection, call the Building Department for scheduling the inspection. Please provide the Permit Number, Address and Type of inspection. (ROUGH, FINAL, REINSPECTION, ETC.).

Expiration of permit: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A permit will be closed when no inspections are requested and conducted within six months of the date of issuance or the date of a previous inspection. Closed permits cannot be refunded or reinstated.
