- 2. Alterations and repair work determined by Plumbing Official to be of a minor nature.
- 3. Buildings with required plumbing fixture count less than 12.
- 4. Work completed by a governmental subdivision or state agency costing less than \$15,000.00.

VI. HOMEOWNER AFFIDAVIT

VII. FEE CLARIFICATION

Item #2. Mobile Home Unit Site: When item is used for sewer excavations in a new park, the permit application should include the application fee plus the number of unit sites. When setting a mobile home in a park, or a mobile or modular home on private property, a permit should include the application fee, a sewer or building drain, and a water service or water distribution pipe.

Item #21. Domestic Water Treatment and Filtering Equipment: A license is not required for the installation of domestic water treatment and filtering equipment that modification to an existing cold water distribution supply and associated water piping in buildings if a permit is secured, required inspections performed and that complies with applicable code. If the enforcing agency determines a violation exists, it shall be corrected by the responsible installer. The permit application shall include the application fee, the number of water treatment devices recorded in item #25 for \$5.00 each and appropriate water distribution pipe (system) size fee.

IX INSTRUCTIONS FOR COMPLETEING APPLICATION

General: Plumbing work shall not be started until the application for permit has been filed. All installations shall be in conformance with the Michigan Plumbing Code. No work shall be concealed until it has been inspected. When ready for inspection, call the Building Department for the inspection to get scheduled. You will need to provide Permit Number, the Address, and the Type of inspection (UNDERGROUND, ROUGH, FINAL, REINSPECTION, ETC.)

Expiration of Permit: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after commencing the work. A permit will be closed when no inspections are requested and conducted within six months of the date of issuance or the date of a previous inspection. Closed permits cannot be refunded or reinstated.

METHOD OF PAYMENT

Via USPS (Mail) Credit Card. Call 1-800-272-9829. At the prompt enter Jurisdiction Code **7065**. After authorization you will be given a confirmation number. Official Payments charges a nominal fee.(DISCOVER, MASTER CARD, AND AMERICAN EXPRESS)
