VI. HOMEOWNER AFFIDAVIT

VII. FEE CLARIFICATION

Item #17, Mobile Home Unit Site:

When installing a site service in a park, the permit application must include the application fee, service, plus the number of park sites.

When setting a HUD mobile home in a park, a permit must include the application fee and feeder. This shall be done by a licensed contractor.

When setting a HUD mobile home or a premanufactured home on private property, a permit must include the application fee, service and feeder.

IX. INSTRUCTIONS FOR COMPLETING APPLICATION

General: Electrical work shall not be started until the application for the permit has been filed. All installations shall be in conformance with the Michigan Electrical Code. No work shall be concealed until it has been inspected and approved.

When ready for an inspection, call the Building Department for scheduling the inspection. Provide the job location, Permit Number, and Type of Inspection being requested.

Expiration of Permit: A permit remains valid as long as the work is progressing and inspections are requested and conducted.

A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing work.

A permit will be closed when no inspections are requested and conducted within six months of the date of issuance of the date of the previous inspection.

Closed permits cannot be refunded or reinstated.
