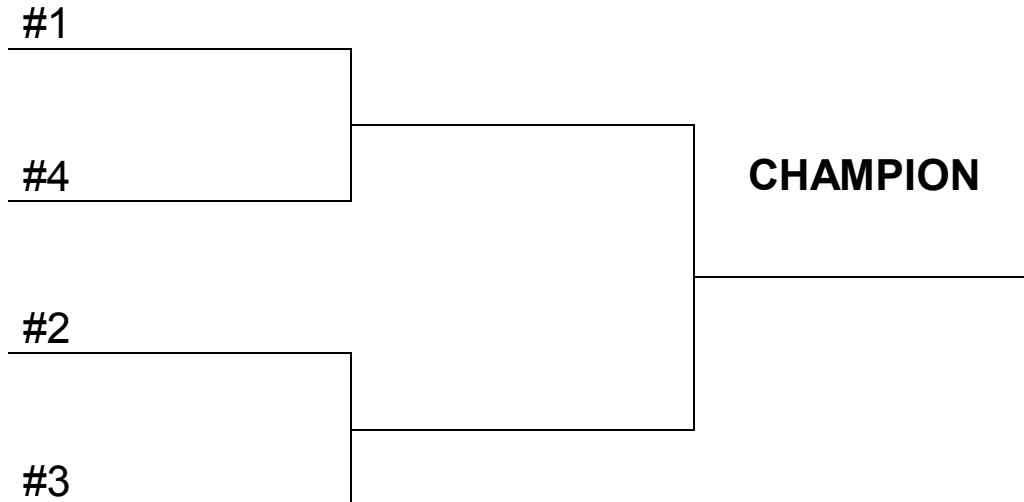

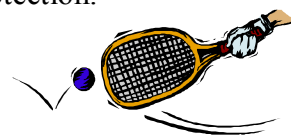

## **General Information**

1. All games should be played during the scheduled week. If deviations are made from this, the League Director should be contacted.
2. Fee includes entry into league, building admittance, court reservation fees and use of the courts for scheduled league games. **Use of other activity areas is not included.**
3. **Scheduling games and courts.**
  - a. Contact scheduled opponent to arrange court time.
  - b. Reservations must be made for all league games. Reservation and court fees for the league are included in the league fee.
  - c. All league players may reserve courts up to 5 days in advance. (810) 664-4431
  - d. Reservations are available to be scheduled on the hour. Reservations will be held for 10 minutes past the scheduled time.
  - e. Check-in is required at the front desk prior to play.
  - f. When you call to reserve a court please indicate who your opponent is and what week the matchup is.
4. At the conclusion of each match, the winner should fill out a score sheet at the front desk.
5. Guests must follow Rules and Regulations of the Community Center. Rules and Regulations are posted and are available upon request.
6. Participation in this program is at your own risk.
7. Proper safety equipment must be worn while using racquetball courts, eye protection.



## **Racquetball League Rules**

1. Three games to 15 points will be played at each match, win by two with a cap at 20.
2. Scores for each game will be recorded on the score sheet. Total points for the match (three games per match) should be totaled on the score sheet. Wins and losses will also be recorded.
3. Participants will be seeded for the playoffs based on league play. Playoffs are in conference format, seeding by conference and conference champions go to play in the finals. Points will be used as means for tie breaker to assess playoff bracket seeding if necessary.
4. If all three games cannot be finished during the reserved time, the player who is ahead at the conclusion of the hour is the winner, unless both players have agreed upon another means of scoring prior to play.
5. The league champion will be based on the tournament style playoff winner.
6. Games need to be played during the specified week. If there is a problem getting a match played the Racquetball League Director must be notified, or after two weeks the match will be counted as losses for both players. Special circumstances have to be passed through the Racquetball League Director 664-4431.
